# TOWN OF MANGONIA PARK REGULAR COUNCIL MEETING JANUARY 7, 2014 6:00 P.M.



7C. Request for the Approval of Outside Storage Application No. 2014-01, B.T. Glass & Mirror, 5770 Columbia Circle, PCN: 44 43 43 05 16 000 0070, Lot 7, Mangonia Park IN Complex, Mangonia Park, FL 33407.

Scott Taylor, Owner, presented the items to be stored on the site.

A lengthy discussion ensued.

Attorney Ashton asked for clarity on the stored items.

Vice Mayor McConnell specifically asked if the five (5) trailers and three (3) vehicles belong to his company and the applicant responded that only the three (3) vehicles belonged to the company; the trailers belonged to one of partners and was not related to the business.

More discussion followed.

Councilwoman Greene said she was not in favor of Vice Mayor McConnell's comments about the property owner using the business site for personal storage.

Councilwoman Greene announced that she had to leave early.

Councilwoman Johnson said the business has a designated intent and the plans are

Councilwoman Johnson also reiterated Mr. Alvin Johnson's strategic planning resume that she placed in their mailboxes for review.

3. Mark K. Trueblood, Council Member, informed the Town Council that he would like for legal to research a lottery type event for the sale of 5701 Briarwood Street.

A lengthy discussion ensued.

Councilman Trueblood stated that he would like to revisit the issue of outside storage in the Industrial Zoning District. He said it should be reconsidered – the storing of personal items in the Industrial Zoning District – domestic and non-domestic, commercial and noncommercial. He said that he is in support of the Industrial Zoning District property owners being allowed this type of leniency.
