

**RESOLUTION NO. 2014-15**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MANGONIA PARK, FLORIDA APPOINTING THE SUPERVISOR OF ELECTIONS, OR DESIGNEE, AS A MEMBER OF THE TOWN OF MANGONIA PARK CANVASSING BOARD; REQUESTING THE SUPERVISOR OF ELECTIONS, OR DESIGNEE, TO CANVASS ALL ABSENTEE BALLOTS, TO CANVASS THE MUNICIPAL ELECTION, AND TO CONDUCT THE LOGIC AND ACCURACY TESTING FOR ALL ELECTION MACHINERY; AUTHORIZING THE TOWN CLERK, OR HER DESIGNEE, TO DO ALL THINGS NECESSARY TO CONDUCT THE GENERAL ELECTION AND RUN-OFF ELECTION, IF APPLICABLE; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Town of Mangonia Park will conduct its municipal election on March 10, 2015; and

**WHEREAS**, the Town Council of the Town of Mangonia Park, Florida, desires that the Supervisor of Elections, or her designee, conduct the logic and accuracy testing for all election machinery to be utilized by the Town in the general municipal election on March 11, 2014, and to publish all necessary legal advertisements; and

**WHEREAS**, the Town Council also desires to appoint the Town Clerk, or her designee, and the Supervisor of Elections, or her designee, as the Town Canvassing Board in order that they may jointly act to canvass all absentee ballots on behalf of the Town and to publish the legal notices required by Chapter 102, Florida Statutes; and

**WHEREAS**, the Town Council also desires to appoint the Town Clerk, or her designee, and the Supervisor of Elections, or her designee, as the Town Canvassing Board in order that they may jointly conduct the municipal election, canvass the election for the Town and then certify the results to the Town of Mangonia Park.

**WHEREAS**, the Town Council deems approval of this Resolution to be in the best interests of the health, safety, and welfare of the residents and citizens of the Town of Mangonia Park and the public at large.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MANGONIA PARK, FLORIDA, THAT:**

**SECTION 1.** The foregoing recitals are hereby affirmed and ratified.

**SECTION 2.** The Town Council hereby appoints the Town Clerk, or her designee, and the Supervisor of Elections, or her designee, as members of the Town Canvassing Board

and requests that the Supervisor of Elections, or designee, conduct the logic and accuracy testing for all election machinery and tabulation equipment for the Town. The Town Council further requests and designates the Town Clerk, or her designee, and the Supervisor of Elections, or designee, to jointly conduct the municipal election and canvass all absentee ballots on behalf of the Town, and further requests and designates the Town Clerk, or her designee, and the Supervisor of Elections, or designee, to jointly canvass the municipal election and to certify the results to the Town of Mangonia Park with respect to the March 10, 2015 general election and any necessary run-off election, if applicable, and to publish the required legal notices with regard to these two actions.

**SECTION 3.** The Town Clerk of the Town of Mangonia Park is hereby is authorized to send a copy of this Resolution to Susan Bucher, Supervisor of Elections, and to do all things necessary to conduct the Town's Municipal election on March 10, 2015.

**SECTION 4.** This Resolution shall take effect immediately upon passage.


