The Town of Mangonia Park Town Council Final Public Budget Hearing was held at 1755 East Tiffany Drive, Mangonia Park, Florida. MOTION made by Councilwoman Johnson, seconded by Councilman Trueblood adjourning the hearing at 5:51 p.m. **Vote was unanimous.**


