In accordance with F.S. 287.133 (2) (a), persons and affiliates who have been placed on the convicted vendor list may not submit bids, contract with, or perform work (as a contractor, supplier, subcontractor or consultant) with any public entity (i.e. Town of Mangonia Park) in excess of Twenty Five Thousand Dollars (or such other amount as may be hereafter established by the Florida Division of Purchasing in accordance with F.S. 287.017) for a period of 36 months from the date of being placed on the convicted vendor list.

The Town of Mangonia Park reserves the right to reject any or all Bids, to waive informalities, and to re-advertise. Criteria utilized by the Town of Mangonia Park for determining the lowest most responsive/responsible bidder includes, but is not limited to, quality of service, commitment, rates and distribution of costs, whether the bidder meets the Town of Mangonia Park's published specifications, the bidder's experience, skill, ability, business judgment, financial capacity, location of manpower and equipment resources, integrity, possession of the necessary facilities or equipment, previous performance, reputation, responsiveness, and any other factor which could reasonably be asserted as being relevant to successful performance.
