2. **PUBLIC HEARING** TO CONSIDER AND MAKE RECOMMENDATIONS TO THE TOWN COUNCIL AMENDING THE TOWN CODE OF ORDINANCES AT APPENDIX A. ZONING. SECTION 5, DEFINITIONS. TO CREATE NEW DEFINITIONS FOR THE TERMS "MARIJUANA," "MEDICAL MARIJUANA RETAIL CENTER," "MEDICAL MARIJUANA RETAIL/TREATMENT CENTER PREMISES," AND "MEDICAL MARIJUANA TREATMENT CENTER"; AND TO REVISE THE DEFINITION FOR "RETAIL SALES AND SERVICE" TO EXCLUDE MEDICAL MARIJUANA RETAIL CENTERS AND MEDICAL MARIJUANA TREATMENT CENTERS THEREFROM; FURTHER AMENDING APPENDIX A. ZONING. AT SECTION 9. DISTRICTS. TO REVISE DISTRICT USE REGULATIONS BY ADDING MEDICAL MARIJUANA RETAIL CENTER AND MEDICAL MARIJUANA TREATMENT CENTER AS NEW SPECIAL EXCEPTION USES IN THE INDUSTRIAL DISTRICT; FURTHER AMENDING SECTION 12. INDUSTRIAL DISTRICT. AT SUBSECTION 3 TO PROVIDE REFERENCE TO THE SPECIAL EXCEPTION USES IN THE SCHEDULE OF DISTRICT REGULATIONS; AND FURTHER AMENDING SECTION 12. INDUSTRIAL DISTRICT. TO CREATE AN ENTIRELY NEW SUBSECTION 8 PROVIDING REGULATIONS FOR THE LOCATION AND USE OF MEDICAL MARIJUANA RETAIL CENTERS AND MEDICAL MARIJUANA TREATMENT CENTERS IN THE TOWN.
